POST RESULTS SERVICE (PRS) INFO

If you are not happy about your results, you should first speak to your teacher/SLT. The exam boards offer a post result service (with some options chargeable). The prices listed below are to give you an idea of the costs the exam boards charge. Full lists of the charges will be available on results day.







EXAM RESULTS SUMMER 2024 CONTINUED



Please note charges are per paper.

•Service 1: Clerical re-check (£9-13 per paper)

o The marks are checked and added up. No questions are re-marked or reviewed

o Deadline: 26th September 2024

•Service 2: Review of Marking (L2 GCSE £40-62, L3 GCE £47-76 per paper)

o All questions checked to see if they have been marked correctly and fairly. The paper is not re-marked,

o Deadline: 26th September 2024

•Priority Service 2: Review of marking (£56-76 per paper)

o GCE A-Level qualifications only. Use if a university place is at risk.

o All questions checked to see if they have been marked correctly and fairly. The paper is not re-marked! Rapid turnaround of outcome.

o Deadline: 22nd August 2024

•Service 3: Review of Moderation (£250-285)

o Moderation of NEA work for the whole class/cohort.

o All students whose work is involved will have to confirm agreement of the moderation.

o Deadline: 26th September 2024

APPEALING RESULTS

Following the outcome of the RoRs, if you are still not happy you can appeal to the exam boards. Cost: £120-270

For all of these services, your grades are not protected. They could go up, stay the same – or go down!

Full payment and the completed & signed "Post Result service: Request, Consent and Payment" form needs to be handed to **Ms L. Hobden, Exams & Data Officer,** before any requests can be processed.

If your grade goes up, the exam boards will give a full refund.

Teachers cannot request any PRS without your consent.

None of these services can be requested before you have received your results.
